BAUN Corporate Membership Benefits & Terms and Conditions

1. BAUN endorsement of company educational material.

- a. Educational material may be submitted for approval of the educational content. If judged to be satisfactory, the BAUN logo can be featured on the material, together with the words 'Educational content approved'
- b. Each member is permitted to make one application for educational material per year of corporate membership. Additional requests for content approval may be processed but will incur an additional charge of £1000.
- c. Enhanced credibility amongst urology nursing professionals

2. BAUN endorsement of company study/educational days. Corporate members - £1,000 VAT + Travel and accommodation (non-members £1,750)

- a. BAUN will endorse company study/education days for fee stated, subject to approval of the programme.
- b. Company can request the presence of a BAUN representative (travel and accommodation must be covered)

3. Product Surgeries

- Corporate members £1,250 (non-members £1,750)
- a. 1 hour to present to BAUN council post council meetings
- b. Opportunity to meet with a panel of senior urology professionals to discuss aspects of emerging or existing technology and products.

4. Link from BAUN Web Site

- a. Corporate members will have a direct link from the BAUN web site to the company web site.
- b. The web site link will be in the name of the company only.
- c. The web site link will be set up from the designated 'Corporate Members' Section of the web site

The link in no way implies endorsement of the company or its products.

5. Priority booking of BAUN Annual Conference and Exhibition space

- a. BAUN will give priority booking of exhibition space to corporate members at the BAUN Annual Conference and Exhibition.
- **b.** Priority booking will apply for a three week period prior to information being sent out to non- members. The exhibitor prospectus and exhibition plan, along with a stand booking form will be sent to corporate members by post or email on the same day. No association liability will arise as a result of any failure on the part of the postal service or email to deliver the prospectus to arrive with all corporate members at the same time.
- c. The exhibitor prospectus and exhibition booking form will be sent only to the senior manager designated on the corporate membership application form.
- d. In order to prevent difficulties which may arise as a result of the senior manager being on holiday at the time of despatch of the booking material, BAUN will publish details of the dates when the material will be posted to corporate members in the BAUN Newsletter immediately preceding the booking period.
- e. Priority booking will apply to all corporate members on a first come, first served basis, within the three week booking period.
- f. Priority booking will only apply to the annual national conference and exhibition and not to any other business group event or interest group event.

6. Free loose insert into BAUN Newsletter and acknowledgement in newsletter

- a. Each corporate member will be entitled to place a single loose insert into any one edition of the BAUN Newsletter during the year of corporate membership with the charge of placing the loose insert being waived.
- b. The insert to be placed as a loose insert with the newsletter will not exceed 30gms in weight and will be provided by the company. Alternatively, the company may send an electronic version of the loose insert for printing in mono (black and white) or colour. If copying in mono is requested a charge of 4p per copy will be made to the corporate member or 16p per copy for colour.
- c. The cost of supplying the loose insert to the distribution point will be met by the corporate member.
- d. The corporate member may choose any edition of the newsletter when placing a loose insert but is

- e. Deadline booking dates for both adverts and the receipt of loose inserts are printed routinely in the BAUN Newsletter when space allows. Corporate members may request a copy of the booking deadline dates and publication dates from the association secretariat at any time.
- f. The value to the company is £236.00

7. Use of BAUN Corporate Member logo

- a. Corporate members will be allowed the use of the BAUN corporate member's logo on company headed paper, compliment slips and business cards.
- b. Where corporate membership is not renewed it is incumbent on the corporate member to cease using the logo with effect from the last day of the month of membership.

- d. BAUN will provide these deadline dates to the corporate members on an annual basis.

- a. A BAUN Conference and Exhibition plaque which identifies the company as a corporate member will be provided for corporate members for display on the company exhibition stand at the BAUN Conference and Exhibition.
